THE ACADEMY IS DESIGNED TO EQUIP PRIVATE AND PUBLIC SECTOR LEADERS ACROSS THE TEN COUNTIES OF MIDDLE TENNESSEE WITH THE PERSONAL AND GROUP TOOLS TO LEAD CONVERSATIONS ABOUT THE VALUE OF MASS TRANSIT ACROSS THE REGION AND ABOUT THE EMERGING MASS TRANSIT OPTIONS THAT CAN ADDRESS OUR MASS TRANSIT NEEDS. A TOTAL OF 24 STUDENTS FROM ACROSS THE TEN COUNTY REGION GRADUATED IN 2013.
