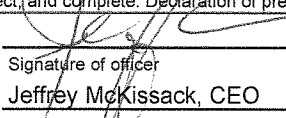

Services include Pediatrics, Internal & Family Medicine, OB/GYN, Dental, Pharmacy, and Behavioral Health services. MWCHC has 2 additional satellite sites in other middle Tennessee counties. MWCHC is accredited through the Joint Commission under the accreditation of Health Care Organizations, certified through the Federal Drug Administration, and certified by the American Dental Association.
