WE ARE ABLE TO HOUSE UP TO 28 RESIDENTS AT A TIME IN A THERAPEUTIC SETTING THAT OFFERS WOMEN SURVIVORS A PEACEFUL PLACE WHERE THEY CAN EXPERIENCE TRANSFORMATIVE, SUSTAINABLE RECOVERY THROUGH TWO YEARS OF RENT-FREE HOUSING, HEALTHCARE, COUNSELING, EMPLOYMENT, AND COMMUNITY BUILDING. WHEN ENTERING THE PROGRAM, OUR RESIDENTS HELP CREATE THEIR OWN PERSONALIZED PLAN FOR THEIR HEALTHCARE AND THERAPEUTIC NEEDS. FOR THE FIRST 4-6 MONTHS, RESIDENTS FOCUS ON RECOVERY, ATTENDING GROUP MEETINGS, MEDICAL APPOINTMENTS, INDIVIDUAL THERAPY, AND OTHER EDUCATIONAL COURSES.
