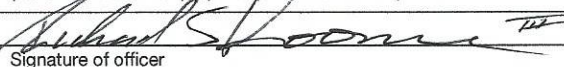

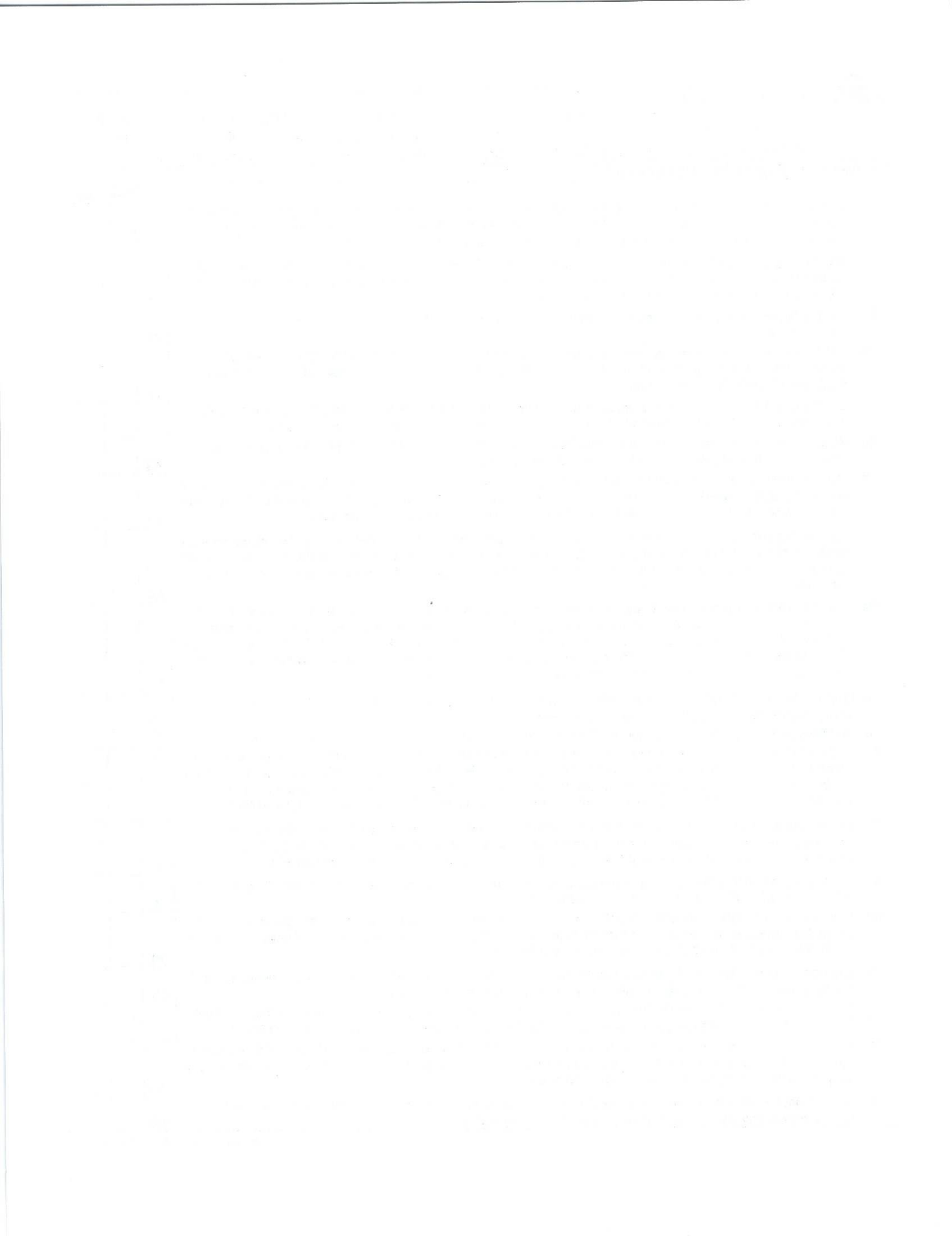

Last year, we made 305 deliveries of food to households representing 757 individuals, almost half of whom were minors (under 18) or seniors (65+) - including 191 children age 12 and under. In over half of the visits, prayer or spiritual encouragement took place. This was accomplished through the efforts of volunteers from Nashville churches who made the deliveries, visited families and offered prayer and encouragement. Many more friends helped with collecting and sorting food into boxes for delivery. We served households throughout Metropolitan Nashville. The contribution of services by volunteers has a value in the range of \$14,000, in addition to cash funds spent on program expenses, and is included in expenses designated here.

It is a useful tool for the design and analysis of control systems.
