Each workshop provides a huge jump start to spiritual, emotional, behavioral, and relational healing. In response to the restrictions required during the COVID-19 pandemic in 2020, Bethesda Workshops moved to a fully online program for the individual intensives. The modified version of our in-person workshop maintained our highly effective model in a psychoeducational/supportive format focused on Sex Addiction and Recovery 101. In 2021, eight workshops were still conducted online, however, in April we began to be back in-person and by July all workshops were in-person.
