Each workshop provides a huge jump start to spiritual, emotional, behavioral, and relational healing. Bethesda Workshops also provides training for clinicians and pastors to equip them to better serve this population. Bethesda Workshops offers five separate programs serving these populations: male sex addicts, female sex addicts, partners of sex addicts (called "co-addicts"), sex addict/co-addict couples and teen sex addicts and their parents. In the twelve months covered by this Form 990 (January 1 - December 31, 2019), Bethesda Workshops served a total of 315 workshop participants.
