Each workshop provides a huge jump start to spiritual, emotional, behavioral, and relational healing. Bethesda Workshops also provides training for clinicians and pastors to equip them to better serve this population. Bethesda Workshops offers four separate programs serving these adults populations: male sex addicts, female sex addicts, partners of sex addicts (called "co-addicts"), and sex addict/co-addict couples. In the twelve months covered by this Form 990 (January 1 - December 31, 2017), Bethesda Workshops served a total of 317 workshop participants.
