NUTRITIOUS FOODS ARE PROVIDED IN RESPONSE TO THE PATIENT'S DIAGNOSIS WITH SPECIAL CARE FOR DIABETES, HYPERTENSION AND CANCER. RESOURCES ARE MAXIMIZED BY PAYING FOR SHELF STABLE PRODUCTS FROM SECOND HARVEST FOOD BANK, WHEN POSSIBLE. NGH FOUNDATION INITIATED THE OUTREACH FOOD PROGRAM DURING THE 2020 TORNADO AND COVID-19 PANDEMIC TO PROVIDE VOLUNTEER-DELIVERED FOOD BAGS TO THOSE IDENTIFIED IN THE COMMUNITY WITH FOOD INSECURITY.
