Re: LWVN Proposed Budget for FY 2023-24

Listed below is the proposed League of Women Voters of Nashville Budget for FY2023-24 for your review before a final membership approval vote at the Annual Meeting on June 4, 2023. The LWVN Board approved this proposed budget on April 13, 2023. (The Nashville budget also includes income and expenses for the League of Women Voters of Williamson County until they form a separate chapter, which is expected during the fiscal year.)

Income is estimated to be about the same as FY2022-23. Initiatives included in the budget include:

- \$3,000 for two in-person events related to the mission of the LWVN, e.g. Legislative Forum and Lunch in 2023
- Up to \$10,000 for an update to the functionality and content of the LWVN website and operational technical consulting, as needed
- An additional \$1,000 for delegate stipends for the LWVUS Conference
- \$5,000 for Community Forums related to the Metro Nashville August 2023 elections
- \$10,000 for Community Outreach focused on encouraging registered voters to vote in August 2023 and to use the LWVN VOTE411 Voter Guide
- \$5,000 to possibly hire a Voter Services Coordinator to assist in organizing and coordinating voter registration events for LWVN members.
