Developed by the Children's Defense Fund, our summer academies are specially designed for at-risk families of color. Tuition, curriculum, books, and meals are free for families we serve. Through our six-week summer literacy program, Nashville Freedom Schools' Scholars receive daily instruction of the award-winning Integrated Reading Curriculum(C), 1-2 books each week to build their personal library, engage educational activities and artistic projects to build vocabulary and critical thinking skills and learn to become change agents in their community. After navigating the COVID-19 pandemic our summer academy will return to in-person programming for Summer 2022.
