Faith Family Medical Clinic is a primary care medical clinic serving uninsured working people (and their families) in the greater Nashville area. Dedicated physicians, nurse practitioners and physician assistants emphasize the healing of the whole person - physically, emotionally, and spiritually. The vision of Faith Family Medical Clinic is that all working uninsured people and their families have access to the medical care they need.

Form 990, Part III, Line 4a - Program Service Accomplishments

Faith Family Medical Clinic provides services in family medicine, diagnostic lab testing, wellness program and individual and/or family counseling. In order to provide comprehensive health care services to patients, the organization has an extensive network of specialist physicians who see our patients at a reduced cost or no cost. We also have relationships with imaging centers where basic X-rays, CAT scans and MRIs can be done for a reduced fee. Specialty care is available through physicians who volunteer at the Clinic for internal medicine, orthopedics, ENT, gynecology and dermatology and a physical therapist. We have strong relationships with area hospital systems and other health care nonprofits.

Patients pay between \$15 and \$40 based on their income and number of dependents.

Patient fees cover only a small portion of our yearly budget; the balance is provided by grants and private donations from caring individuals, foundations, churches and businesses.

To be eligible for treatment, individuals must not have any form of health insurance (including TennCare, CoverKids, Medicare or Medicaid); individuals must be either working at least 20 hours per week OR be receiving unemployment benefits OR be a

fulltime student. Spouse and dependents are also eligible for care.

During the last calendar year, Faith Family Medical Clinic had 9,643 patient visits, with an average of 38 patient visits per day. We added 943 new patients. We had 153 counseling sessions and made 584 specialist referrals and 792 imaging referrals.

In addition to the Clinic's staff, 53 volunteers provided us with 1,891 hours of donated services. These hours included: 5 physicians, 5 nurses, 1 physical therapist, 1 certified nurse technician, 15 administrative, 1 information technician, and 14 emergency technicians. In addition we had 22 volunteers participate on our Breakfast Committee, 1 company donate legal services, and 1 company donate video-taping services at the Breakfast.
