Twenty-three local affiliates and one campus club served family members and persons living with severe and persistent mental illness. Board meetings including officers and regional representatives were held quarterly and minutes are available. Our successful state conference drew hundreds of participants. The NAMI TN helpline served thousands of diverse citizens. Several classes were conducted for the care providers of adult consumers as well as education classes for primary care providers for children with mental illness.

Part VI 11a - The Board of Directors have quarterly meetings that don't allow time to review before the deadline to file the Form 990. The

Executive and Deputy Directors review the form and schedules before filing. The complete form will be presented to the Board at

their next meeting. The Board and all members will have access to the forms on our website.

Part VI 15a - Executive Director's salary is set by the Board of Directors based upon experience, budget and market conditions.
