AFTER A THOROUGH DISCUSSION, THE BOARD SHALL RENDER A DECISION AS TO WHETHER THEY FEEL A CONFLICT OF INTEREST EXISTS. IF THE BOARD FEELS THAT A CONFLICT OF INTEREST VIOLATION TOOK PLACE, THEY WILL INTERVIEW THE PARTY INVOLVED AND LISTEN TO ANY MITIGATING INFORMATION THE INDIVIDUAL HAS. IF THE BOARD FEELS THE VIOLATION WAS WILLFUL, THEY WILL RECOMMEND APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION. THEY WILL ALSO ORDER THE INDIVIDUAL TO CEASE AND DESIST FROM ANY RELATIONSHIP THAT WAS RELATED TO THE VIOLATION.

NOTE: EACH PERSON COVERED UNDER THIS POLICY SHALL BE REQUIRED TO SIGN, ANNUALLY, A CONFLICT OF INTEREST STATEMENT. THIS FORM WILL HAVE TO BE DEVELOPED WHEN THE POLICY HAS BEEN APPROVED DUE TO THE NECESSITY FOR MAKING SURE THE FORM IS COMPATIBLE WITH POLICY REQUIREMENTS.
