Notes to Financial Statements

Ladies of Charity Welfare Agency, Inc.

For the year ended December 31, 2008

1. Significant accounting policies and principles

Ladies of Charity Welfare Agency, Inc., is a not for profit organization which is exempt from federal income tax as provided for in the Internal Revenue Code Section 501(C)3 for charitable organizations.

The Agency uses fund accounting to record cash receipts and disbursements. Fund accounting is a generally accepted accounting principle which is used by non profit entities to demonstrate stewardship of funds entrusted to their care. Thus there is no retained earnings or equity account such as would be found in a commercial enterprise. The agency also uses the accrual method of accounting to recognize revenue when earned and expenses when incurred.

2. Organizational structure and governance

The Ladies of Charity Welfare Agency, Inc., is a non-denominational charitable agency which was founded by the Ladies of Charity of Nashville, Inc., a non-profit Catholic women's civic and social club which engages in philanthropic activities. The Agency provides services without regard to race, creed or nationality. The executive board of the Ladies of Charity of Nashville, Inc., is also the board of directors of the Ladies of Charity Welfare Agency, Inc.

3. Primary function and activities

The Ladies of Charity Welfare Agency, Inc., provides emergency assistance to individuals and families who cannot be serviced immediately by other social service agencies. For example, it administers funds provided for Nashville Electric Service to assist needy persons with their electric bills.

The Agency receives public support primarily through the Ladies of Charity of Nashville, Inc., and the United Way of Middle Tennessee with a small amount of direct public contributions. The Agency is currently seeking funding

from a number of foundations in order to broaden its base of support.

The Agency uses all of its funds in direct program services. All administrative and fund raising expenses are assumed by the Ladies of Charity of Nashville, Inc.

4. Dealings with related parties

The Ladies of Charity Welfare Agency, Inc. is completely controlled by the Ladies of Charity of Nashville, Inc. The facilities, building and furnishings are supplied by the Ladies of Charity of Nashville, Inc. Ladies of Charity provides fundraising and administrative support to the Agency.
