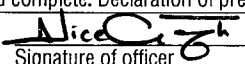

Emergency grants were awarded to parties who met our criteria on a first come, first serve basis. We used 100% of all public support to pay expenses for sick and injured animals. Grants were paid to veterinarians to cover expenses for animals with conditions like: Parvo, heartworm, bladder infections, ear infections, ear mites, flea infestation, anemia, dehydration, tick borne illnesses, worms and other parasites, fevers and seizures. Other animals were struck by cars and sustained broken bones, head injuries, open wounds and nerve damage. Other animals, sadly, were thrown from cars or jumped from open windows of cars only to be struck by automobiles. Diseases and accidents know no holidays, and many emergencies cannot wait. Because we do not want any animal to suffer, we answer grant requests 365 days a year.

4b (Code:) (Expenses \$ 4200. including grants of \$ 4200.) (Revenue \$)

In May, 2010, Nashville and other parts of Tennessee suffered devastating flood damages. We made emergency flood grants to rescue organizations who were harboring displaced pets. Grants were given to Metro Nashville Animal Control, Happy Tales Humane, New Leash on Life, Proverbs 12:10 and Hope's Haven.

Our education program, Creature Care, was piloted in two Metro Nashville Schools. Creature Care is designed to teach children about animals' needs and feelings. Our program also embraces the "whole child" concept that Metro has adopted. Not only do children learn about humane treatment of animals, they also gain self confidence and take part in academic activities like art, writing and music. Each classroom gets a book, a backpack and a CD containing the "Creature Care Song". The children can share the book during the school term and are encouraged to relive their classroom experience by writing a story or drawing a picture. Secondly, children learn how to avoid being bitten by animals. Our long-term goal is to have humane education be part of every school. Currently, we are the only local program in
