NOA ADVANCES ITS MISSION IN THREE WAYS: MAINSTAGE PRODUCTIONS (4 PER SEASON), OUTREACH PROGRAMS (TAKING OPERA OUT OF THE PHYSICAL THEATER AND INTO THE COMMUNITY), AND ARTIST TRAINING (THE HBCU FELLOWSHIP AND THE MARY RAGLAND EMERGING ARTISTS).
