As a result of our work, The Equity Alliance was named The Tennessean's "2020 People of the Year."

The Coronavirus Pandemic impacted our organization substantially in how we pivoted our operations and our programming goals. Covid-19 stopped us from getting outside like we wanted and forced us to come up with ways to use digital organizing and relational organizing tactics that reached people in a socially distant, culturally relevant way. We utilized phone banking, text messaging, social media, traditional media, online chat groups,

business and community influencers, and cultural phenomena like Verzuz battles on Instagram and Juneteenth celebrations. We also launched a podcast, in partnership with the TN Holler, called Porch Politics, with the idea that since we cannot leave our house, we will have "real and raw" conversations from our porch about current political, social and economic issues. Episodes are livestreamed on Facebook and rebroadcast on Apple iTunes and Spotify.

After deadly tornadoes on March 3, we mobilized 600+ volunteers to clean up North Nashville and engaged over 300 homeowners to host town halls with disaster experts to educate them on keeping and repairing their homes. More than \$75,000 was provided in direct cash assistance to 125 families.

This initiative ensured marginalized communities were not left out of receiving federal CARES Act COVID-19 relief funding. It delivered \$10 million in housing and utility relief, and \$5 million for small businesses. Read the full report at ourfairsharenash.com.

In response to the murder of George Floyd by state-sanctioned violence in Minneapolis, we organized the first protest in downtown Nashville in defense of Black lives.

In summer 2020, we filed a federal lawsuit to expand absentee ballot access so that every Tennessean could vote safely during the Covid-19 pandemic. More than 200,000 voters were impacted with absentee ballot access by way
