TQEEPR issued a grant to TQEE for several purposes: To support lobbying of the Tennessee General Assembly and other state policymakers; to support a digital and social media marketing program; and to support administration costs including management and accounting.

TQEEPR retains a public relations firm to support the organization's efforts to engage media to help create awareness and educate the public and policymakers about the importance and value of quality early care and education programs.

TQEE-PR deploys field organizing staff to build and activate our 28,000+ member coalition as well as cohort group coalitions. In 2020, the field organizing team grew the TQEE mayors coalition to 135 county and city mayors from across the state; they engaged the rural prek coalition of 117 rural area leaders in creating awareness of the importance of Pre-K expansion in their communities; and they helped recruit 100+ early education advocates from across the state to participate in our Day on the Hill.
