CHARTER
(Articles of Incorporation)

OF

WEST NASHVILLE DREAM CENTER

We, the undersigned, of full age, for the purpose of forming a religious & charitable non-profit corporation pursuant to the provisions of Tennessee Code Annotated § 48-52-105 and amendments (Tennessee Nonprofit Corporation Act), certify that at a regular meeting of the undersigned incorporators held on the 9 day of November 2016, in Nashville, Tennessee, did associate ourselves as a nonprofit body corporation and did adopt the following Charter.

ARTICLE I — NAME

The name of the corporation is WEST NASHVILLE DREAM CENTER, (hereinafter referred to as the "Corporation").

ARTICLE II – TYPE OF CORPORATION/ MEMBERS

This corporation is a non-for-profit religious corporation. The corporation will not have members.

ARTICLE III — PRINCIPAL OFFICE/ REGISTERED AGENT

The principal office, and initial registered office of the Corporation is to be located in Davidson County, Tennessee, at 4007 Delaware Avenue, Nashville, TN 37209.

The name and address for the Corporation's initial registered agent for service of process is: Ryan Bult, West Nashville Dream Center, 4007 Delaware Avenue, Nashville, TN 37209.

ARTICLE IV — PURPOSE

The Corporation is organized exclusively for charitable, religious, and educational purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purposes of the Corporation are to provide (a) religious and charitable resources and a safe environment for the families of our local community; and (b) relief of the poor and distressed or underprivileged.

The Corporation shall not be conducted or operated for profit and no part of the net earnings of the Corporation shall inure to the benefit of any individual, nor shall any of the profits or assets
