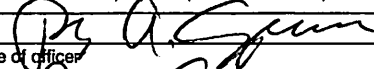

Total enrollment runs 80-120 students per 6 week session.

Performances - (1) Snap on 2&4 performance series - held on the 2nd and 4th Fridays of each month in the Jazz Cave, the Organization's venue. Performances by Nashville's top jazz artists in a smoke-free, listening-room setting (2) Contemporary Jazz Series - the first Sunday of each month featuring emerging artists' music. Special residency programs with nationally-known artists. Attendance averages 60-70 per performance.
