THE TRANSIT ALLIANCE OF MIDDLE TENNESSEE WAS VERY ACTIVE DURING 2011, ITS SECOND YEAR OF EXISTENCE MAJOR ACTIVITIES UNDERTAKEN DURING THE YEAR TO PROMOTE THE PROGRAM OF ENCOURAGING SUPPORT FOR NEW INVESTMENTS IN MASS TRANSIT INCLUDED SIGNIFICANT COMMUNICATION OF TRANSIT NEEDS AND OPTIONS ACROSS ALL TEN COUNTIES OF MIDDLE TENNESSEE, SUPPORT FOR THE MAYORS CAUCUS OF MIDDLE TENNESSEE, CREATION OF THE TRANSIT CITIZEN LEADERSHIP ACADEMY, AND, ONGOING FUNDRAISING AND ADMINISTRATIVE DEVELOPMENT THE TRANSIT ALLIANCE WAS A MAJOR PRESENTER AT OVER 90 REGIONAL EVENTS THESE EVENTS WERE HELD IN ALL TEN COUNTIES OF MIDDLE TENNESSEE AND INCLUDED SERVICE CLUBS, LOCAL LEGISLATIVE BODIES, PROFESSIONAL ORGANIZATIONS AND NEIGHBORHOOD MEETINGS THESE PRESENTATIONS INCLUDED DISCUSSION OF REGIONAL TRANSPORTATION NEEDS AND POSSIBLE TRANSIT OPTIONS THE TRANSIT ALLIANCE MAINTAINED A SIGNIFICANT WEBSITE PRESENCE (WWW.THETRANSITALLIANCE.ORG) AND A FULL RANGE OF SOCIAL MEDIA CONNECTIONS USING TWITTER, FACEBOOK AND TRADITIONAL EMAIL COMMUNICATIONS OVER 600 ESTABLISHED CONTACTS FOLLOWERS ARE INCLUDED IN THESE NETWORKS IN 2011, THE TRANSIT ALLIANCE WAS AN ACTIVE PARTICIPANT WITH THE MAYORS CAUCUS OF MIDDLE TENNESSEE AS THE CAUCUS BEGAN DEVELOPMENT OF BOTH COST ESTIMATES FOR TRANSIT OPTIONS AND POSSIBLE LOCAL DEDICATED REVENUE SOURCES TO FUND SUCH OPTIONS THE TRANSIT ALLIANCE PARTICIPATED IN MAYORS CAUCUS MEETINGS AND WAS INVITED BY CAUCUS MEMBERS TO PARTICIPATE IN TRANSIT DISCUSSIONS ACROSS THE REGION IN 2011, THE TRANSIT ALLIANCE ACHIEVED ONE OF ITS PRIMARY OBJECTIVES WHEN IT ESTABLISHED THE TRANSIT CITIZEN LEADERSHIP ACADEMY (TCLA) WORKING WITH THE NELSON AND SUE ANDREWS INSTITUTE FOR CIVIC LEADERSHIP AT LIPSCOMB UNIVERSITY, TCLA WAS ESTABLISHED WITH FUNDING FROM THE TRANSIT ALLIANCE AND A NUMBER OF REGIONAL SPONSORS, INCLUDING MAJOR SUPPORT FROM THE GREATER NASHVILLE ASSOCIATION OF REALTORS WITH A GOAL OF ESTABLISHING A CORE OF CIVIC LEADERS WHO COULD GUIDE DISCUSSIONS OF FUTURE TRANSIT OPTIONS, TCLA INAUGURATED ITS FIRST CLASS OF 34 STUDENTS IN THE FALL OF 2011 FOLLOWING A SEVEN-SESSION CURRICULUM, THE CLASS GRADUATED IN OCTOBER, 2011 A SECOND CLASS WAS RECRUITED IN LATE 2011, AND IT, WITH SUBSEQUENT CLASSES, WILL LEAD TO AN ALUMNI GROUP OF NEARLY 100 CIVIC LEADERS BY THE END OF 2012 IN 2011, THE TRANSIT ALLIANCE CONTINUED THE RECRUITMENT OF FINANCIAL SUPPORTERS TO UNDERGIRD ITS WORK BOTH INDIVIDUAL AND BUSINESS SUPPORT WAS OBTAINED A SUMMER INTERN ALLOWED THE DEVELOPMENT OF ADMINISTRATIVE CAPACITY, INCLUDING MEETING SCHEDULING AND PREPARATION OF MATERIALS IN-KIND SUPPORT OF BROCHURES AND PRESENTATION MATERIALS WAS PROVIDED BY SEVERAL BUSINESSES AS WELL AS IN-KIND SUPPORT FOR OFFICE SPACE LATE IN 2011, THE TRANSIT ALLIANCE BECAME ACTIVELY INVOLVED IN SUPPORT THE REGIONS FIRST NEW MAJOR TRANSIT INITIATIVE THE EAST WEST CONNECTOR PROJECT BEING INITIATED BY THE METROPOLITAN TRANSIT AUTHORITY ADMINISTRATIVE COORDINATION WITH THE MTA AND PROJECT STAFF WILL LEVERAGE BOTH TRANSIT ALLIANCE RESOURCES AND PROVIDE THE PROJECT WITH ACCESS TO CIVIC LEADERS WHO ARE CONNECTED WITH THE TRANSIT ALLIANCE
