 NAMI Tennessee provides programs, training and leadership for grass-roots advocates that run our local affiliate groups. Volunteers in 20 local affiliates provide free education classes, facilitate support groups and drive advocacy efforts serving individuals with mental health conditions, their family members and the mental health professionals who serve them. Support: Local affiliates provided over 260 peer-to-peer support groups with over 2,200 individuals participating. The NAMI Tennessee helpline served thousands of diverse callers providing local, state, and national resources. Education: Over 150 individuals participated in free care giver education classes (NAMI Family to Family and NAMI Basics). Over 250 individuals received professional-in-service training to enhance professional skills. Advocacy: 215+ individuals received Grass-roots advocacy training on engagement with policy makers.

 The Crisis Intervention Team (CIT) in Tennessee program is made possible with a Federal grant award from the United State Dept. of Justice (DOJ), Office of Justice Programs (OJP) Bureau of Justice Assistance (BJA) through its Justice and Mental Health Collaboration Program (JMHCP).
 The grant seeks to support the development, implementation and sustainment in an 8 county rural region of the State of Tennessee. There are 8 counties served under this grant:
 White, Sumner, Putnam, Wilson, Overton, Smith, Dekalb and Cumberland
 The CIT Model is a solution focused community response to helping people with mental illness by bringing stakeholders together from law enforcement, behavioral health and advocacy sectors, along with people with lived experience of mental illness, to develop solutions for safely redirecting people in crisis away from the judicial system and into the behavioral health care system whenever appropriate. The centerpiece of the model is forty (40) hours of specialized training for a select group of police officers who volunteer to become CIT officers.
