During the year, hundreds of dogs, cats and other animals benefited from vet assistance payments. Over 300 animals were helped with emergency vet care. Payments were awarded by application to low-income pet owners and rescuers. Applications were taken 365 days a year in order to respond quickly to prevent suffering or death. Several other animals were assisted with major surgeries and treatments that went beyond the limits of our subsidy payments. These animals were helped with payments made to "angel funds" and used to cover these particular animals' veterinarian expenses. Animals were treated for

We collaborated with Pet Community Center at one of their wellness events. While Pet Community Center was treating pets, we were providing new leashes and collars for pets as well as bags of food. These events take place in neighborhoods that have the highest surrender rates to animal control. The goal of these events is to provide basic health services and supplies that will assist owners in keeping their pets. Another goal is to encourage pet owners to neuter their pets. Some pet owners cannot afford required vaccinations, tags and collars, food, and other basic items. These events help reduce owner surrenders by filling that need.
