### 2012 TIMELINE OF GROWTH

**January** Moved to West Nashville United Methodist Church and doubled our office and programming space. Betty Kayitesi began serving as Director of Social Services

**February** Offered 3 citizenship classes and hosted 3 PREP Vanderbilt interns

**May** Received funding from the Tennessee Office for Refugees to begin a job placement and training program

**August** Joined World Relief's Immigration Legal Support Network

**September** A record number of volunteers served on a weekly basis

**October** Received a Refugee Student Impact Grant to launch a new after-school tutoring and home work help site

**December** A record number of churches and individuals make financial gifts to support our on-going outreaches



**A** Congolese family of 7 moved to Nashville in July 2012 after being resettled by the US government in Idaho. They lived temporarily with family and friends. We **welcomed** them and quickly **connected** them to our programs. We helped them register for school, apply for housing, and get their food stamps transferred. Nations Ministry's Job Coach started searching for jobs. Six months later, Nations Ministry Center **celebrates** this family's success as they are now in a rental house fully furnished NMC donors. Mom, Dad and the oldest son are all working and driving legally!



**W**e met Yona in October 2012 after his family migrated to Nashville from the family's resettlement city of Kansas City, Missouri, in May 2012. His family originally comes from Burundi, but Yona was born and lived in Tanzania before being resettled in the US. We **connected** him to our new after-school tutoring program where he receives one-on-one help with algebra and English. Often feeling overwhelmed all day at school, he felt

disheartened in his quest to learn English. At Nations Ministry, he works on Rosetta Stone and receives individualized tutoring with a volunteer. Yona's progress has been inspiring. A smile leaps to his face every time he masters a concept in English and algebra.

**A**lmost five years ago, 19-year-old Hsar Shee and his family arrived in the US as refugees from Burma. His father began working in warehouse production, and his older brother found a job. Hsar Shee was able to graduate from high school and enroll at Nashville State. The family of six soon earned enough to rent a house. Just a few months ago, his father lost his job because of an injury he sustained away from work. Soon after, his brother was injured at work and cannot work again for quite some time. Hsar Shee did not want to quit school, and his parents did not want to lose their house, so the brothers needed employment immediately. His brother found a job on his own, but Hsar Shee needed help. Last fall, Nations Ministry **connected** him to a job in food services at the airport. He now works part-time at Auntie Anne's while continuing to study at Nashville State. In this job, he will gain employment skills and can save money to help him achieve his dream to become a nurse.
