The Minerva Foundation provides grants for various youth initiatives that we support within the Nashville Metropolitan Community. The programs include: Delta Academy - program initiative for girls ages 11-14 to participate in hands-on experiments in chemistry, biology and physics. Delta GEMS - program initiative for African American at risk adolescent girls ages 14-18 that offers a roadmap for college and career planning. EMBODI - program initiative for African American males to address the plight of this group through dialogue, recommendations for change and action. Program focuses on leadership, physical and mental health, character and ethics, college readiness and civic engagement.

The Foundation also provides meeting space at the Cultural Center, supplies, food and other materials.
