The Children's Health Executive Oversight Committee provides high-level oversight for the city-wide effort to make Nashville America's 'Healthiest City for Children.' The Mayor's Office of Children and Youth, Metro Nashville Public Schools, Vanderbilt Children's Hospital, Metro Public Health Department and several other community and business partners support the following 5 committees: Healthy Starts, Primary Care, Healthy Eating and Active Living, Adolescent Sexual Responsibility, and Behavioral Health Committee. MNPS is implementing Coordinated School Health (CSH) across the district with help from Alignment Nashville committees. Our collaboration and coordination combine to form the Children's Health Initiative.
