KIDS MINISTRY--OUR SUMMER IS FOR KIDS MINISTRY GREW TO SERVE APPROXIMATELY 1,100 MEALS OVER THE SUMMER IN 2019. SUNDAY MORNING AVERAGE WAS 10-18 KIDS AGAIN. WE EXPANDED OUR KIDS PROGRAMMING IN COMMUNITY NIGHT BY REPLICATING COMMUNITY NIGHT TO HAPPEN THREE NIGHTS A WEEK INSTEAD OF ONE.
