Bethesda Workshops conducts intensive four-day therapeutic workshops for recovery from sexual addiction and co-sex addiction. Each workshop provides a huge jump start to spiritual, emotional, behavioral, and relational healing. Bethesda Workshops also provides training for clinicians and pastors to equip them to better serve this population. Bethesda Workshops offers four separate programs serving these adults populations: male sex addicts, female sex addicts, partners of sex addicts (called "co-addicts"), and sex addict/co-addict couples. In the twelve months covered by this Form 990 (January 1 - December 31, 2016), Bethesda Workshops served 160 male addicts, 40 female addicts, 85 co-addicts, and 27 couples for a total of 312 workshop participants.
