RECLAIMING PUBLIC SPACE IS AN INITIATIVE OF THE NASHVILLE CIVIC DESIGN CENTER AIMED AT IMPROVING THE BUILT ENVIROMENT FOR USE BY ALL PEOPLE. OUR COMMUNITY PARTNERS AT CONEXION AMERICAS LAUNCHED THE COMMUNITY ENGAGEMENT PROJECT ENVISION NOLENSVILLE: COMMUNITY, CREATIVITY, AND IMAGINATION IN PLACEMAKING PROJECT. THE DESIGN CENTER PARTICIPATED IN 4 CREATIVE LABS THAT IDENTIFIED WHAT PEOPLE THAT LIVED AROUND THE NOLENSVILLE CORRIDOR WANTED FOR THEIR NEIGHBORHOODS. THE INFORMATION AND IDEAS FROM THE LABS WAS COLLECTED AND VISUALIZED BY THE CIVIC DESIGN CENTER IN A REPORT RELEASED THIS PAST SUMMER.

TURBO, WHICH STANDS FOR TACTICAL URBANISM ORGANIZERS, IS THE ACTION ARM OF THE CIVIC DESIGN CENTER. IT WAS FOUNDED BY A GROUP OF PASSIONATE NASHVILLIANS DEDICATED TO CREATING THREE-DIMENSIONAL CHANGE IN COMMUNITIES'-SPECIFICALLY IN REGARDS TO BEAUTY, SAFETY, AND MOBILITY. TACTICAL URBANISM USES METHODS, WHICH ARE TYPICALLY SMALL AND OFTEN TEMPORARY CHANGES TO THE BUILT ENVIROMENT THAT IDEALLY TURN INTO PERMANENT CHANGES OVER TIME. EXAMPLES OF TACTICAL URBANISM CAN RANGE FROM A BUS STOP, BENCHES AND SHELTERS, TO TEMPORARY BIKE LANES AND CROSSWALKS. AT THIS YEAR'S TOMATO ART FEST, TURBO WAS ASKED TO INSTALL A LARGE SCALE POP-UP PARK. THE PARK FEATURED SEATING, GAMES, AND ENTERTAINMENT THAT PATRONS COULD ENJOY FOR FREE. THE OBJECTIVE WAS TO BRING AWARENESS TO THE NEED AND BENEFITS OF PUBLIC SPACE.

THE ALLIANCE FOR GREEN HILLS HAS EMBRACED IDEAS FROM SHAPING THE HEALTHY COMMUNITY AND WANTED TO SHOW WHERE THESE IDEAS FROM THE BOOK COULD BE IMPLEMENTED SO THEY REACHED OUT TO THE TURBO FOR ASSISTANCE TO CREATE A POP-UP PLAZA IN THE CENTER OF GREEN HILLS DURING THE HOLIDAY SEASON TO RAISE AWARENESS FOR WALKABLE CONNECTIONS IN THE SHOPPING DISTRICTS OF GREEN HILLS.

THE CIVIC DESIGN TEAMED UP WITH METRO PUBLIC WORKS AND GEHL STUDIO AND PLANNING TO SURVEY PUBLIC SPACE IN DOWNTOWN NASHVILLE IN OCTOBER. WITH THE AMAZING HELP OF OVER 50 VOLUNTEERS, TWO DAYS AND NIGHTS OF PEDESTRIAN ACTIVITY WERE COLLECTED TO CREATE A BASELINE OF PEDESTRIAN DATA THAT CAN BE USED TO INFORM ENHANCEMENTS ALONG LOWER BROADWAY AND OTHER DOWNTOWN CORRIDORS. THIS POP-UP PARKLET ON 2ND AVE WAS CREATED BY THE DISTRICT, THE LOWER DOWNTOWN PARTNERSHIP AND TURBO AS PART OF THE SURVEY.

THE NASHVILLE CIVIC DESIGN CENTER FACILITATED A FOUR-WEEK SUMMER CAMP, FUNDED BY THE NATIONAL ENDOWMENT FOR THE ARTS, CALLED DESIGN YOUR NEIGHBORHOOD. THE YOUTH WHO PARTICIPATED SHOWED GROWTH IN THEIR AWARENESS OF HOW THE WORLD IS BUILT AROUND THEM, AND WERE EMPOWERED TO MAKE CHANGES IN THEIR OWN COMMUNITIES. THEY ALSO DEVELOPED SKILLS IN MAPPING, NEIGHBORHOOD DESIGN AND CIVIC ENGAGEMENT.

AT OUR ANNUAL LUNCHEON LAST YEAR, WE ANNOUNCED A GRANT FROM THE JAMES STEPHEN TURNER FAMILY FOUNDATION TO FUND A SERIES OF YOUTH FOCUSED INITIATIVES AND AN EDUCATIONAL CURRICULUM. THIS PAST SUMMER, NDCDC ONCE AGAIN OFFERED DESIGN YOUR NEIGHBORHOOD, PROVIDING PAID SUMMER INTERNSHIPS TO 11 HIGH SCHOOL STUDENTS FROM A DIVERSE RANGE OF SCHOOLS ACROSS DAVIDSON COUNTY. THE INTERNSHIP ALIGNS WITH MAYOR BARRY'S OPPORTUNITY NOW PROGRAM THAT PROVIDES PROFESSIONAL SKILLS DEVELOPMENT AND EMPLOYMENT OPPORTUNITIES FOR YOUTH.

IN ADDITION TO THE INTERNSHIP PROGRAM, AN EDUCATIONAL CURRICULUM IS CURRENTLY BEING DEVELOPED AND PILOTED FOR GRADES 7-10, WITH A GOAL OF URBAN DESIGN AND CIVIC ENGAGEMENT BEING A REGULAR PART OF EDUCATION IN

WE WENT ON TOURS OF THE AMAZING PROJECTS THAT WERE DESIGNED AND BUILT BY AUBURN STUDENTS, AND CONCLUDED THE DAY WITH A SPECIAL DINNER WHERE WE WERE JOINED BY THE RURAL STUDIO FACULTY AND STUDENT. THE NEXT DAY WE TOURED BIRMINGHAM, MET WITH THE URBAN DESIGN STUDIO AND VISITED SLOSS FURNACES AND THE GORGEOUS RAILROAD PARK.
