COMMUNITY LAND TRUST (CLT) IS A STEWARDSHIP PROGRAM TO PROTECT COMMUNITY ASSETS AND PROVIDE PERMANENTLY AFFORDABLE HOUSING OPPORTUNITIES FOR GENERATIONS OF LOWER-INCOME FAMILITES AND COMMUNITIES. THE METHOD BY WHICH IT ACCOMPLISHES THIS IS CALLED "SHARED EQUITY OWNERSHIP". METRO NASHVILLE, IN CONJUNCTION WITH THE BARNES FUND HAS DONATED 15 PROPERTIES VALUTED AT \$485,900 TO THE HOUSING FUND FOR THE PURPOSE OF CLT. THESE ARE SCATTERED SITE PROPERTIES IN THE FOLLOWING ZIP CODES: 37207, 37208, 37210 AND 37218. THE HOUSING FUND WILL CREATE HOUSING ON THESE PROPERITES AND FIND LOW TO MODERATE INCOME FAMILITES TO PURCHASE THESE HOUSES AND SIGN A GROUND LEASE WITH THE HOUSING FUND. A GROUND LEASE IS AN AGREEMENT BETWEEN CLT AND THE BUYER WHICH OUTLINES THE TERMS AND CONDITIONS FOR PARTICIPATING IN THE CLT.
