

CRISIS CARE, RESOURCE HOME PREPARATION:

VOLUNTARY PLACEMENTS OF CHILDREN INTO APPROVED RESOURCE HOMES OCCURS WHEN PARENTS OR GUARDIANS ARE IN CRISIS SITUATIONS. AN ALTERNATIVE TO FOSTER CARE WITH THE STATE AGENCY, EFFORTS ARE MADE TO ASSIST THE PARENTS AND CHILDREN TO BE REUNIFIED. TRAINING AND APPROVAL THROUGH HOME STUDIES ENSURE THAT CHILDREN ARE PLACED IN SAFE, STABLE, CARING RESOURCE HOMES. ONGOING TRAINING ENABLES RESOURCE PARENTS TO MEET THE SPECIAL NEEDS OF THE CHILDREN. SAFETY, WELLBEING AND PERMANENCY ARE GOALS FOR EACH PLACEMENT. TWENTY-EIGHT CHILDREN WERE CARED FOR IN 2013 AND THIRTEEN NEW FAMILIES COMPLETED PRE-SERVICE TRAINING. TEN CHILDREN RECEIVED SERVICES IN THEIR HOMES AS A STEP DOWN FROM CRISIS CARE OR AS A MEANS TO PREVENT PLACEMENT INTO CRISIS CARE.
