Report on the Financial Statements

We have audited the accompanying financial statements of Mid-Cumberland Community Action Agency, Inc. (the Agency) (a nonprofit organization), which comprise the statements of financial position as of June 30, 2020 and 2019, and the related statements of activities, functional expenses, and cash flows for the years then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements referred to on the previous page present fairly, in all material respects, the financial position of the Agency as of June 30, 2020 and 2019, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matters

Other Information

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The accompanying schedule of expenditures of federal awards and state financial assistance, as required by Title 2 U.S. Code of Federal Regulations Part 200, *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*, is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated, in all material respects, in relation to the financial statements as a whole.

The introductory section listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements. The directory of board members and management has not been subjected to the auditing procedures applied in the audit of the basic financial statements and, accordingly, we do not express an opinion or provide any assurance on it.

Other Reporting Required by *Government Auditing Standards*

In accordance with *Government Auditing Standards*, we have also issued our report dated March 30, 2021, on our consideration of the Agency's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Agency's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Agency's internal control over financial reporting and compliance.

1. Summary of Significant Accounting Policies

Organization and Nature of Activities

Mid-Cumberland Community Action Agency, Inc. (the Agency) is a private, not-for-profit corporation located in Mount Juliet, Tennessee. The Agency was chartered in 1971 and is a quasi-governmental entity that provides health and educational assistance to low-income households. A board of directors (the Board) governs the Agency and its programs are carried out by staff members under the supervision of the Executive Director, who is appointed by the Board. The Agency operates community action and other human resource programs primarily aimed at the lower income population of selected counties in the middle Tennessee area. The main source of funding is federal government grants received either directly or through a similar department of the State of Tennessee.

The Agency is qualified as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code. It has not been determined to be a private foundation and is considered by the Internal Revenue Service (IRS) to be a public charity. Accordingly, no provision for income taxes has been made. However, the Agency does file informational returns required by the IRS. The Agency is no longer subject to federal or state income tax examinations by tax authorities for fiscal years ended before June 30, 2017.

Use of Estimates

The Agency's financial statements are presented in accordance with accounting principles generally accepted in the United States of America which require the use of management's estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent liabilities, and the reported amounts of revenues and expenses. Actual results could differ from estimates in the near term and variances could have a material effect on the financial statements.

Basis of Accounting

Basis of accounting refers to when revenues and expenses are recognized in the accounts and reported in the financial statements. The Agency utilizes the accrual basis of accounting which recognizes revenues when earned and expenses when incurred. Operating revenues and expenses include those items that increase or decrease unrestricted net assets.

The Financial Accounting Standards Board (FASB) has established standards concerning contributions and financial statement presentation applicable to non-governmental not-for-profit organizations such as the Agency. These standards require that unconditional promises to give (pledges) be recorded as receivables and revenues and require the Agency to distinguish among contributions received for each net asset category in accordance with donor-imposed restrictions. A description of the two net asset categories follows:

Basis of Accounting (Cont'd)

Net Assets Without Donor Restrictions

Net assets without donor restrictions are free of donor-imposed restrictions. All revenues, gains and losses that are not restricted by grants or donors are included in this classification. All expenditures are reported in the net assets without donor restrictions class of net assets since the use of restricted contributions in accordance with the grantors' or donors' stipulations results in the release of the restriction.

Net Assets With Donor Restrictions

Net assets with donor restrictions are limited as to use by donor- or grantor-imposed restrictions. Some restrictions expire with the passage of time or may be satisfied by use for the specific purpose. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. The Agency's net assets with donor restrictions consisted of funds due from grantor agencies at June 30, 2020 and 2019.

Concentrations of Credit Risk/Funding

Financial instruments that potentially subject the Agency to significant concentrations of credit risk consist principally of cash and receivables. The Agency is exposed to credit risk by placing its cash in financial institutions. The Agency has mitigated this risk by placing its cash with federally-insured financial institutions. The Agency receives grants from both the federal and state government and local assistance from the City of Murfreesboro. Funding from these sources constituted 95.8% and 98.3% of revenues for the years ended June 30, 2020 and 2019, respectively. The Agency would have to greatly reduce services provided if assistance was significantly reduced. All outstanding grants receivable are from governmental agencies. The Agency does not obtain collateral for receivables.

Uncertainties

In early March 2020, the COVID-19 virus was declared a global pandemic, and it began to significantly impact many individuals and businesses worldwide. Business continuity, including supply chains and consumer demand across a broad range of industries and countries, could be severely impacted for months or more, as governments and their citizens take significant and unprecedented measures to mitigate the consequences of the pandemic. Management is carefully monitoring the situation and evaluating its options during this time. No adjustments have been made to these financial statements as a result of this uncertainty, to include any estimate of loss or impairment of assets that may result. Such changes may occur rapidly and be substantial.

Cash and Cash Equivalents

The Agency considers all highly-liquid debt instruments purchased with maturities of 90 days or less to be cash equivalents.

Investments

The Agency's investments consist of one mutual fund investment recorded at market value. At June 30, 2020 and 2019, the market value of the mutual fund was \$22,596 and \$22,596, respectively, with a cost basis of \$13,452. The investment is unrestricted and can be used for general expenditures.

Federal Grants Receivable

Grants receivable are stated at unpaid balances and consist of balances due from federal and state agencies as summarized in Note 4. Management has elected to use the direct write-off method which is not materially different from the allowance for uncollectible accounts method. It is the Agency's policy to charge off uncollectible receivables when management determines the receivable will not be collected. All receivable balances are considered by management to be fully collectible.

Inventory

Inventory consists of food for the Temporary Emergency Food Assistance Program. Inventory is valued at the per-unit value as determined by the State of Tennessee Department of Agriculture using the first-in, first-out method for financial statement reporting purposes and is included in temporarily restricted net assets.

Property and Equipment

Property and equipment, including leasehold improvements, are recorded at historical cost or, if contributed, at estimated fair values at the date of receipt. Property and equipment acquired with a unit cost greater than \$5,000 and a useful life of more than one year are capitalized. Expenditures for additions, major renovations and improvements are capitalized while those for maintenance and repairs are charged to expense as incurred. Capitalized assets are depreciated over their estimated useful lives using the straight-line method.

Included in net property and equipment at June 30, 2020 and 2019 is \$-0- and \$498,564, respectively, of assets purchased with restricted resources. The Head Start grant was relinquished effective October 31, 2019. All of the fixed assets purchased with Head Start funds were transferred to the interim management company. See Note 13 for capitalized assets transferred from the interim management company to the Agency after June 30, 2020.

Revenue Recognition

Grants and contributions received are recorded as net assets without donor restrictions or net assets with donor restrictions, depending on the existence and/or nature of any restriction. Grant revenues are recognized as the related expenditures are incurred.

Functional Expenses

The costs of providing various programs and other activities have been summarized on a functional basis in the statements of functional expenses. Accordingly, certain costs have been allocated among the programs based on the revenue allotted to each of those programs.

Advertising Costs

The Agency expenses advertising costs as incurred.

Change in Accounting Principle

In April 2016, FASB issued Accounting Standards Update 2014-09, *Revenue from Contracts with Customers (Topic 606)*. The Agency implemented this standard during the year ended June 30, 2020 and has applied it retrospectively. The implementation of this new revenue recognition standard had no impact on the Agency's revenue reporting but required the addition of Note 12.

During the year ended June 30, 2020, the Agency adopted ASU 2016-18, *Statement of Cash Flows (Topic 230): Restricted Cash*. This new accounting standard requires restricted cash activity to be reported on the statement of cash flows. Since the Agency has reported this activity in the statement of cash flows, the implementation of this new standard had no impact on the Agency's statement of cash flows, but required the addition of cash reconciliation in Note 1.

The Agency also adopted ASU 2018-08, *Not-For-Profit Entities (Topic 958): Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made*, which establishes standards for characterizing grants and similar contracts with resource providers as either exchange transactions or conditional contributions. This ASU has been adopted retrospectively but did not impact the Agency's financial statements.

Date of Management's Review

Subsequent events have been evaluated through March 30, 2021, which is the date the financial statements were available to be issued.

2. Cash and Cash Equivalents

Cash and cash equivalents were represented by deposits in financial institutions totaling \$360,121 and \$639,942, at June 30, 2020 and 2019, respectively, of which \$263,063 and \$263,061, respectively, was insured by the Federal Deposit Insurance Corporation (FDIC), and \$97,058 and \$376,881, respectively, was uninsured. Restricted cash represents unearned grant revenue.

3. Liquidity and Availability

The Agency maintains a policy of structuring its financial assets to be available as its general expenditures, liabilities and other obligations come due. The Agency's working capital and cash flows have seasonal variations during the fiscal year attributable to timing of cash receipts for program services. Additionally, the Agency receives support from government agencies through annual grants which are paid on an expense reimbursement basis, typically within 45 days of the request for reimbursement.

6. Profit-Sharing Plan

The Agency has a defined contribution profit-sharing plan that covers full-time employees of the Agency over age 21 and having at least one year of service. Contributions to the plan are discretionary and are determined annually by the board of directors. The Board elected to contribute 5% of eligible compensation to the plan for the years ended June 30, 2020 and 2019. The amount of this contribution was \$118,450 and \$311,023, respectively.

7. Compensated Absences

The Agency advances vacation leave to employees at the beginning of each fiscal year on July 1. Unused vacation leave cannot be carried forward past the grant year-end of the program the employees work in, i.e., Head Start employees cannot carry forward balances past the program year-end of October 31. At June 30, 2020 and 2019, the estimated leave liability was \$13,468 and \$44,085, respectively.

A substantial number of unpaid volunteers have made significant contributions of their time to support the Agency's programs. 9. Operating Leases

The Agency leased office space, classrooms, and equipment under operating leases. The total paid for these leases was \$352,025 and \$462,398 for the years ended June 30, 2020 and 2019, respectively. The Agency also leases storage facilities on a month-to-month basis as needed.

The Agency was party to 20-year lease agreements for three of its Head Start facilities which were transferred to an interim management agency effective October 31, 2019 (see Note 13). The Agency made prepayments at the inception of these leases which were being amortized over the lives of the related leases and were recorded as an offset to the monthly lease payments. The remaining prepayment balance of \$-0- and \$142,484 at June 30, 2020 and 2019, respectively, is classified as prepaid rent on the statements of financial position. Due to the events described in Note 13, the prepayment was written off during the year ending June 30, 2020.

10. Contingencies

Funding for the Agency's programs is provided by federal, state, and local government agencies. These funds are to be used for designated purposes only. If, based on the grantor's review, the funds are considered not to have been used for the intended purpose, the grantors may request a refund of monies advanced or refuse to reimburse the Agency for its disbursements. The amount of such future refunds and unreimbursed disbursements, if any, is not expected to be significant. Continuation of the Agency's programs is predicated upon the grantor's satisfaction that the funds are being spent as intended and the grantor's intent to continue its programs.

11. Budget

The Agency prepares annual budgets for each program fund. Prior to the beginning of each budget year, the Agency's annual budget is approved by the Agency's governing body and is submitted to federal and state grantors for approval. Budgetary amendments require approval by the governing body and by federal and state grantors. All budgetary appropriations lapse at the end of each fiscal year.

13. Head Start Grant Relinquishment

Effective October 31, 2019, the Agency relinquished the Head Start and Early Head Start Child Care Partnership grants due to deficiencies identified by Department of Human Services. The interim management agency, Community Development Institute (CDI), assumed Head Start duties as of October 31, 2019. As a result of the relinquishment, the Agency reduced its staff by 178 employees, transferred fixed assets with a book value of \$469,149 to CDI, transferred three Head Start facility leases to CDI, and was reimbursed by CDI for the remaining seven Head Start operating leases during the period of time CDI managed the Head Start grant. The Agency also disposed of Head Start vehicles that CDI did not accept for operations which had an approximate book value of \$29,415.

After implementing processes to address the deficiencies identified by the Department of Human Services, the Agency reapplied and, effective August 1, 2020, was awarded the Head Start/Early Head Start grant for the 2020-2021 grant year. Property and equipment that was previously transferred to CDI was returned to the Agency after June 30, 2020.

14. Subsequent Events

Effective August 1, 2020, the Agency was again awarded the Head Start and Early Head Start Child Care Partnership grants. As a result, the Agency increased its staff by 180 employees, received the fixed assets previously relinquished, and reassumed three Head Start facility leases from CDI.

In August 2020, the Agency was awarded a one-time COVID-19 Head Start grant for \$789,169. In February 2021, the Board approved using a portion of this grant to purchase sanitizing machines totaling approximately \$300,000.

In September 2020, the Agency entered into a 65-month lease for office space and relocated the central office operations from Lebanon, Tennessee to Mount Juliet, Tennessee. Monthly rent will initially be \$12,500 and will gradually increase to \$13,500.

NOTE A – Basis of Presentation

The accompanying schedule of expenditures of federal awards and state financial assistance (the schedule) includes the federal and state grant activity of the Agency and is presented on the accrual basis of accounting. NOTE C – Food Distribution

Nonmonetary assistance is reported in the schedule at the per-unit values as determined by the State of Tennessee Department of Agriculture. At June 30, 2020, the Agency had food commodities in inventory totaling \$367,041.

The Agency did not resolve prior-year findings 2019-003 and 2019-004 related to compliance. The findings recurred in the current year and are reported as findings 2020-001 and 2020-002, respectively.

The Agency's responses to the findings identified in our audit are described in the accompanying schedule of findings and questioned costs. The Agency's responses were not subjected to the auditing procedures applied in the audit of the financial statements and, accordingly, we express no opinion on them.

Purpose of this Report

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Agency's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Agency's internal control and compliance. 5. The Independent Auditor's Report on Compliance with Requirements for Each Major Program and on Internal Control over Compliance Required by the Uniform Guidance dated March 30, 2021, for the major federal award programs of the Agency expressed an unmodified opinion on all major federal programs.
6. No audit findings relating to major programs were required to be reported in accordance under 2 CFR section 200.516(a) of the Uniform Guidance.

RELATED TO INTERNAL CONTROL

2019-001 Management Oversight of Financial Reporting

Condition: The Agency lacks management oversight over the financial reporting processes for the preparation of the financial statements and footnote disclosures in conformity with GAAP. Eight adjusting entries and four reclassification entries was required for the financial statements to be in conformity with GAAP.

Criteria: Proper management oversight over financial reporting should include the preparation of the financial statements and footnote disclosures in accordance with GAAP.

Effect: Decisions could be made based on incomplete or inaccurate financial statements.

Recommendation: We recommend that management implement procedures to ensure that the financial statements are in conformity with GAAP.

Response: A cost-benefit analysis of the financial reporting process deemed it cost-prohibitive to obtain third-party assistance to prepare the financial statements and footnotes in accordance with GAAP prior to the independent audit. However, we believe that our knowledge and experience enables us to review the report and understand it fully. We take full responsibility for the financial statements and all adjusting and reclassification journal entries.

2019-002 Budget Reports

Condition: Budget information contained in the budget-to-actual reports submitted for Board review was inaccurate. Grant contracts were amended but the Agency's budget was not updated.

Criteria: Proper fiduciary responsibility includes providing the Board with accurate budget reports for review.

Effect: Decisions could be made based on incomplete or inaccurate budget-to-actual results.

Recommendation: We recommend that management implement procedures to ensure that the internal budget is updated when a grant contract is amended.

Response: Budget revisions and amendments were submitted to the Board for review; however, due to the changes in program and program year as well as multiple awards for programs within the same fiscal year, the budget-to-actual function of the report was not utilized. However, the Board was provided reports regarding expenses and revenues for each program on a monthly basis.

RELATED TO INTERNAL CONTROL

2019-005 Internal Controls Related to Reporting – CFDA #93.600, Head Start Program, Early Head Start Child Care Partnership, 2018 and 2019; and CFDA #93.569, Community Services Block Grant 2018-2019

Condition: As reported by the U.S. Department of Human Services in their report dated March 4, 2019, the Agency did not have effective internal controls to ensure the timely filing of form SF-425 for the Head Start program and the Early Head Start Child Care Partnership grants. The Agency also did not have effective internal controls to ensure the timely filing of two of two tested monthly CSBG reimbursement requests; both were filed later than the required 30 days.

Criteria: The Agency's Board should be monitoring the reporting requirements for grants.

Cause: The Agency's Board was not monitoring the reporting requirements for grants.

Effect: The Agency submitted reports and reimbursement requests after the due dates.

Recommendation: We recommend that the Agency's reporting procedures be updated to ensure reports are timely filed.

Response: Monthly, quarterly and year-end procedures have been implemented with deadlines and reporting requirements reviewed by the Board to ensure completion of required reports.

RELATED TO COMPLIANCE

2019-006 Timeliness of Reporting – CFDA #93.600, Head Start Program, Early Head Start Child Care Partnership, 2018 and 2019; and CFDA #93.569, Community Services Block Grant 2018-2019

Condition: The Agency did not timely file form SF-425 for the Head Start program and the Early Head Start Child Care Partnership grants. This deficiency was also noted by U.S. Department of Human Services. The Agency also did not timely file two of two tested monthly reimbursement requests for CSBG.

Criteria: Per U.S. Department of Human Services requirements, grantees are required to submit quarterly reports with the grant activity. Per the CSBG contract, monthly invoices are to be submitted within 30 days of the month ending.

Cause: The Agency was not timely with their filings.

Effect: The Agency did not meet the deadline for submitting the Head Start quarterly reports or CSBG monthly reimbursement requests.
