

VOLUNTARY PLACEMENTS OF CHILDREN INTO APPROVED RESOURCE HOMES OCCURS WHEN PARENTS OR GUARDIANS ARE IN CRISIS SITUATIONS. AN ALTERNATIVE TO FOSTER CARE WITH THE STATE AGENCY, EFFORTS ARE MADE TO ASSIST THE PARENTS AND CHILDREN TO BE REUNIFIED. TRAINING AND APPROVAL THROUGH HOME STUDIES ENSURE THAT CHILDREN ARE PLACED IN SAFE, STABLE, CARING RESOURCE HOMES. ONGOING TRAINING ENABLES RESOURCE PARENTS TO MEET THE SPECIAL NEEDS OF THE CHILDREN. SAFETY, WELLBEING AND PERMANENCY ARE GOALS FOR EACH PLACEMENT. THIRTY-EIGHT CHILDREN WERE CARED FOR IN 2012 AND TEN NEW FAMILIES COMPLETED PRE-SERVICE TRAINING. FOURTEEN CHILDREN RECEIVED SERVICES IN THEIR HOMES AS A STEP DOWN FROM CRISIS CARE OR AS A MEANS TO PREVENT PLACEMENT INTO CRISIS CARE.

COUNSELING IS OFFERED TO WOMEN WHOSE PREGNANCY HAS BROUGHT ON ADDITIONAL STRESS AND COMPLICATIONS AND WHO WANT TO LOOK AT OPTIONS RATHER THAN ABORTION. SUPPORT, ACCESS TO RESOURCES AND COUNSELING ASSISTS WOMEN IN DEVELOPING AN INFORMED PLAN THAT WILL EITHER ENABLE HER TO PARENT OR TO PLAN FOR ADOPTION. OPENNESS IS ENCOURAGED FOR ADOPTION PLANS. TWENTY-ONE WOMEN RECEIVED MATERNITY ASSISTANCE IN 2012. ADOPTION SERVICES FOR TWENTY CHILDREN INCLUDES PLACEMENT OF INFANTS, CHILDREN IN FOSTER CARE, AND CHILDREN PLACED THROUGH INDEPENDENT ARRANGEMENTS.
