SINCE 1946, TWF'S EFFORTS TO PERPETUATE THE CONSERVATION AND ENVIRONMENTAL SUSTAINABILITY OF TENNESSEE'S WILDLIFE AND NATURAL RESOURCES HAS BEEN CENTRAL TO TWF'S MISSION, AND FOR THE FIRST-TIME EVER THE FEDERATION NOW HAS A STAFF DEDICATED SOLELY TO THIS EFFORT. THIS HAS LED TO MUCH SUCCESS OVER THE PAST YEAR.
