THE STORE OPERATES AS A YEAR-ROUND FREE GROCERY STORE ALLOWING PEOPLE TO SHOP FOR THEIR BASIC NEEDS. THERE IS NO CHARGE TO THOSE REFERRED OR TO THE PEOPLE AND AGENCIES THAT SEND THEM. THEY MAY SHOP FOR FOOD TO SUPPLEMENT THEIR INCOME DURING TIMES OF CRISIS AND AS THEY WORK TOWARD SELF-SUFFICIENCY. DURING 2023, THE STORE SERVED 416 HOUSEHOLDS BY PROVIDING BI-WEEKLY SHOPPING WHERE CUSTOMERS MAY SHOP FOR THEIR OWN GROCERY ITEMS. SHOPPERS CAN EXPECT TO FIND ITEMS SUCH AS: FRESH PRODUCE, MILK, MEATS, EGGS, AND DIETARY FRIENDLY OPTIONS.
