TENNESSEE'S SALARY INFORMATION FOR EACH POSITION IS GROUPED WITH INFORMATION OBTAINED FROM STATES THAT RECEIVE A SPECIFIED RANGE OF FEDERAL DOLLARS. FOR EXAMPLE, WE MAY RECEIVE INFORMATION THAT FIVE STATES WHO RECEIVE 2.6M AND 3.2M FEDERAL DOLLARS PER YEAR HAVE AN ED SALARY RANGE OF BETWEEN 65K AND 90K PER YEAR. TRADITIONALLY, TN'S EXECUTIVE DIRECTOR'S COMPENSATION HAS FALLEN IN THE MID-RANGE OF SIMILARLY FUNDED PROTECTION AND ADVOCACY SYSTEMS.
