**Afterschool Program: PTM served 300 K-12th grade students in reading development, Christian faith development, and enrichment opportunities. As a result, 66% of students improved their reading level. Also, students were able to take part in 50 field trips throughout the year. 100 students took part in sports programming by playing on a PTM-coached team in a Nashville sports league. This resulted in more parent engagement, more positive peer groups being formed, and greater attendance at afterschool program. Additionally, 75 students were able to participate in a PTM weekend retreat.**

**Summer Program: PTM served 170 students in a seven week summer program (Tuesday - Friday from 9:00 - 4:15) that allowed for over 25 field trips and included arts and crafts, sports, reading, and Bible study. Additionally, 9 PTM high school students worked as part of PTM's summer staff helping them to have a good first job experience.**

**Mentoring Programs: PTM provided one-on-one mentoring through Lunchmate Mentors, Dinner and Devo, Breakfast and Bible Study, SnackChat, and Springbreak in the Marketplace. The combination of these programs allowed PTM to place over 200 youth in relationships with caring adults.**
