Narrow Gate's one and only program is to provide a Christian discipleship experience for young men ages 18-25 by having them live in a wilderness environment, participate in daily chores and community work projects to build teamwork and develop good work disciplines, going on challenging adventures, and studying the Bible and other Christian curriculum to help shape them into godly young men.
In 2009, 31 young men came to Narrow Gate. Some choose to leave Narrow Gate before their class graduates. However, most of these men after graduation either elect to continue their biblical learning by enrolling in the Grace Narrow Gate School of Ministry with a desire to become a pastor after the 1 year extended learning period, go into full time ministry with churches or non-profit organizations, enter universities to study the passion that God gave them, like horticulture, healthcare and business degrees, or elect to serve in the mission field with an organization called YWAM (Youth With A Mission) - such men are serving all over the world including Thailand, New Zealand, China and Israel.
