Early Learning Center - 108 children (6 weeks to 5 years) engaged in key learning experiences which promoted the development of cognitive, language, gross motor, fine motor, social/emotional and self help goals. Programming (NAEYC and DHS 3 Star) emphasizes the acquisition of emergent literacy skills and pre-K readiness skills.

Youth Services
Thrive- 153 youth in K- 12 grade were served after school and summer at three sites achieving the following goals. 1.) 153 students demonstrated their community involvement by creating and implementing an activity that benefits the community. 2.) 94 youth demonstrate their commitment to community service and understanding of citizenship through the planning and implementation of a service learning project. 3.) 94 students increased their awareness of pro-social/emotional behaviors; and 4.) 66 students increased their knowledge of future careers and their individual skills and talents.

Senior Services - 120 elderly or disabled adults received hot, nutritious meals(20,494 total) Monday thru Friday and holidays delivered by volunteers and staff.
Emergency Food Bank Services- In partnership with Second Harvest Food Bank, we operated a community food bank Monday thru Friday serving 3,842 food boxes and 8,370 people annually. On average 290 children were fed weekly through Kids Cafe.
Case Management- In partnership with Metro Social Services the total number of people receiving crisis help. Major categories include rent, utilities, food, medicine, health care, clothing, and educational support.
Social Worker had 922 General case management contacts, Crisis Manager assisted 143 with financial assistance referrals and 50 General case management contacts, School liaison assisted 350 Family/Child case management contacts. (continued on Schedule O)
