SINCE 1946, TWF'S EFFORTS TO PERPETUATE THE CONSERVATION AND ENVIRONMENTAL SUSTAINABILITY OF TENNESSEE'S WILDLIFE AND NATURAL RESOURCES HAS BEEN CENTRAL TO TWF'S MISSION. AN EXAMPLE OF THIS WORK OVER THE LAST YEAR WAS TWF'S LEADERSHIP IN FORMING A COALITION OF TENNESSEE ENVIRONMENTAL AND CONSERVATION ORGANIZATIONS TO PUSH FOR PASSAGE OF THE "FORUM ON TENNESSEE'S GREAT OUTDOORS" THAT WILL BE INTRODUCED IN JANUARY, 2017 IN THE TENNESSEE GENERAL ASSEMBLY.
