 Afterschool Program: PTM served over 120 kindergarten-8th grade students in three afterschool sites. Each site featured reading, math, character education, and enrichment opportunities. Also, 100 students took part in summer programming that followed a similar emphasis. PTM also provided within the context of afterschool programming PTM Life, a running and nutrition program for 20 students. Additionally, 40 students took part in Fun Friday which offered a variety of enrichments designed to open students' eyes to a wide range of opportunities.

4b (Code: ) (Expenses \$ 80115 including grants of \$ 0 ) (Revenue \$ 0 )  
 Calvin House Youth Program: With this program over 50 6th-12th grade students participate in weekly gatherings for a meal, large group games, Biblical instructions, and small group discussions. Additionally, this program offers students two weekend retreats a year, monthly outings, and opportunities for high school students to join in separate weekly small group discussions. Also through this program 30 youth were able to attend Barefoot Camp, a week long Christian camp in Kentucky. Ten high school students participated in Servant and Leadership Training (SaLT). SaLT combines mentoring (each student receives mentoring and provides mentoring to a younger student), academic support, and life skills development.

 Mentoring Programs: PTM students have an opportunity to be in "joy-filled friendships" through a variety of channels. Over 80 students have lunchmate mentors who eat weekly with them. 12 4th-6th grade students met weekly for "Breakfast and Bible Study". In this program each student had an adult mentor. Additionally, 30 students took part in Springbreak in the Marketplace, a program designed to provide job shadowing opportunities for 6th-12th grade students during their spring break.
