BRINGING BOOKS TO LIFE IS AN AWARD-WINNING EARLY-LITERACY PROGRAM THAT HELPS TEACHERS AND PARENTS FOSTER A LOVE OF READING IN CHILDREN THROUGH TEACHER TRAINING, FAMILY LITERACY PROGRAMS AND STORY-RELATED CLASSROOM ACTIVITIES. LAST YEAR, BBTL TRAINED 705 TEACHERS AND ARMED 1,110 PARENTS WITH THE LITERACY TOOLS NEEDED TO INSPIRE READING BOTH AT HOME AND IN THE CLASSROOM.
