Revenue and expenses are for 88 adoptions and 89 dog intakes into the program during 2019. Expenses include veterinarian fees, dog supplies, such as food, collars, leashes, dog toys, heartworm and flea/tick preventatives, and payroll. All dogs are required to be spayed/neutered before adoptions, except for puppies. Puppies are contractually obligated to be spayed/neutered at the proper age. Follow up is performed and evidence gathered to prove compliance. While the dog is in the program, he/she has a complete exam, all medical findings cleared if possible, given monthly heartworm and flea/tick preventatives, and training, if necessary before adoption. The adoption fee is \$200. The average expense of a dog is over \$1,000. Adoption applications are required to be considered to adopt a dog. After the approval of an application, meet and greets and home visits are scheduled to ensure the dog is placed in the best home possible. Our process works as we have less than 1% overall return rate.
