READING IS FUNDAMENTAL VOLUNTEERS VISIT THEIR ASSIGNED ELEMENTARY CLASSROOM FIVE TIMES OR MORE THROUGHOUT THE SCHOOL YEAR. DURING THESE VISITS, THE VOLUNTEERS READ ALOUD TO AND INTERACT WITH THE CHILDREN, THEN ALLOW EACH CHILD TO SELECT A NEW BOOK TO BECOME THEIR VERY OWN. THESE ECONOMICALLY DISADVANTAGED ELEMENTARY CHILDREN BENEFIT GREATLY FROM HAVING A POSITIVE COMMUNITY ROLE MODEL VISIT THEM IN THEIR CLASSROOMS AND HAVING BOOKS TO CHERISH AND BUILD THEIR HOME LIBRARIES.
