The Resettlement Program resettled 69 refugees in 2020. Services included finding housing for clients, setting up health appointments, enrolling children in school, enrolling in eligible benefits programs and referring to ESL classes and employment support.

The Adult Education Program served over 600 clients in 2020. Services included English Language Learner classes (ELL), High School Equivalency preparation classes, work force preparedness and Citizenship instruction.

The Employment Program provided support to approximately 250 clients in 2020. Services provided included skills inventories, on-line and paper job application support, resume development, workforce preparedness and English classes.
