THE CENTER PROVIDES A SAFE HAVEN FOR VICTIMS TO FACILITATE THE INTERVIEW PROCESS BY LAW ENFORCEMENT AND OTHER RELATED AGENCIES. EDUCATIONAL MATERIAL IS ALSO PROVIDED TO THE VICTIMS AND THEIR FAMILIES. Durng the fiscal year 141 interviews were conducted and approximately 440 children served.
