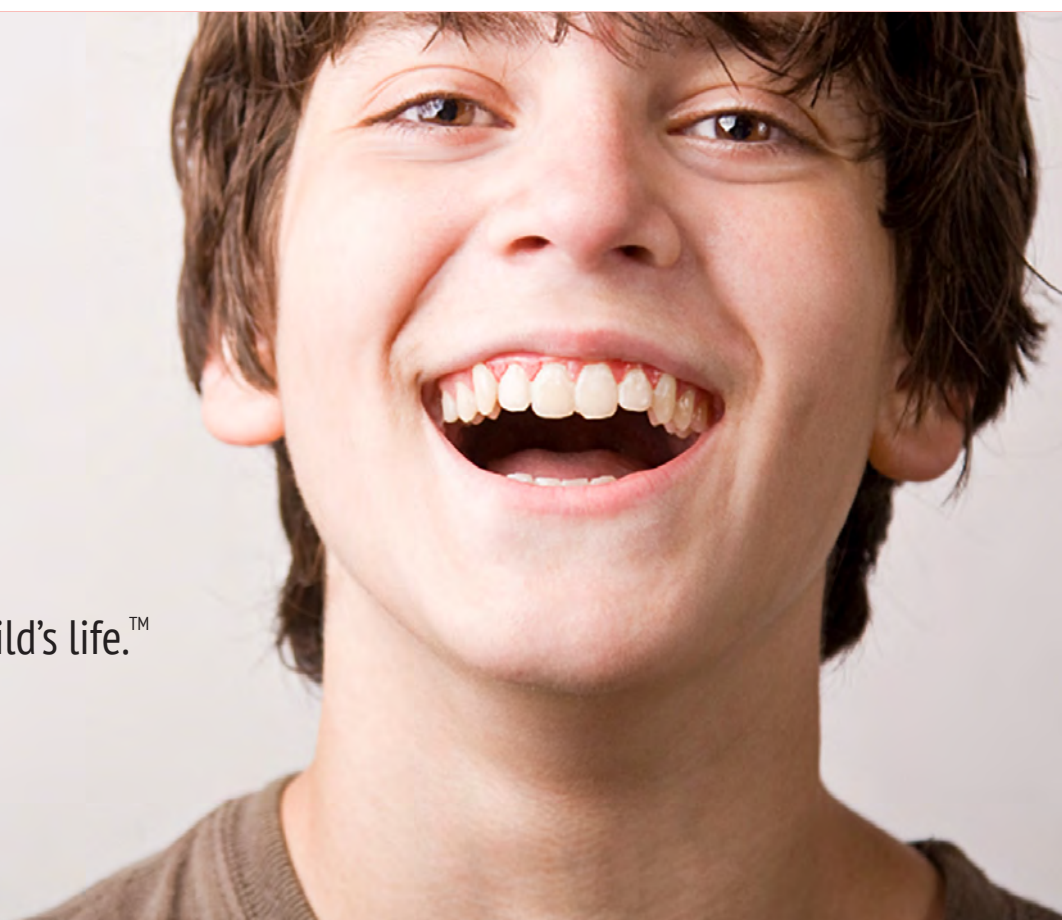




Lift up a child's voice. A child's life.™

Dear Friends,

Every year in Nashville, as many as 800 children in foster care pass through the Davidson County Juvenile Court. These children have been abused, neglected, and abandoned. CASA provides professionally trained and dedicated volunteer advocates to ensure that these children have a voice.

Last year, thanks to the support of hundreds of generous donors, and the incredible dedication and selflessness of 179 Volunteers, CASA was able to provide 479 children with a CASA volunteer Advocate. These Advocates stay with their child from the beginning of the court process until they are placed in a safe, stable home.

**A child represented by a CASA Advocate:**

- is more likely to find a safe, permanent home;
- will receive more needed services while in the court system;
- will spend less time in foster care;
- will do better in school; and,
- is less likely to be bounced from home to home.

As a matter of fact in 2015, 94% of recommendations regarding permanency (where a child will ultimately find a permanent family) made to the court by a CASA volunteer were accepted, and 99% of children going through Davidson County Juvenile Court remained in their safe, stable home for at least six months after that placement.

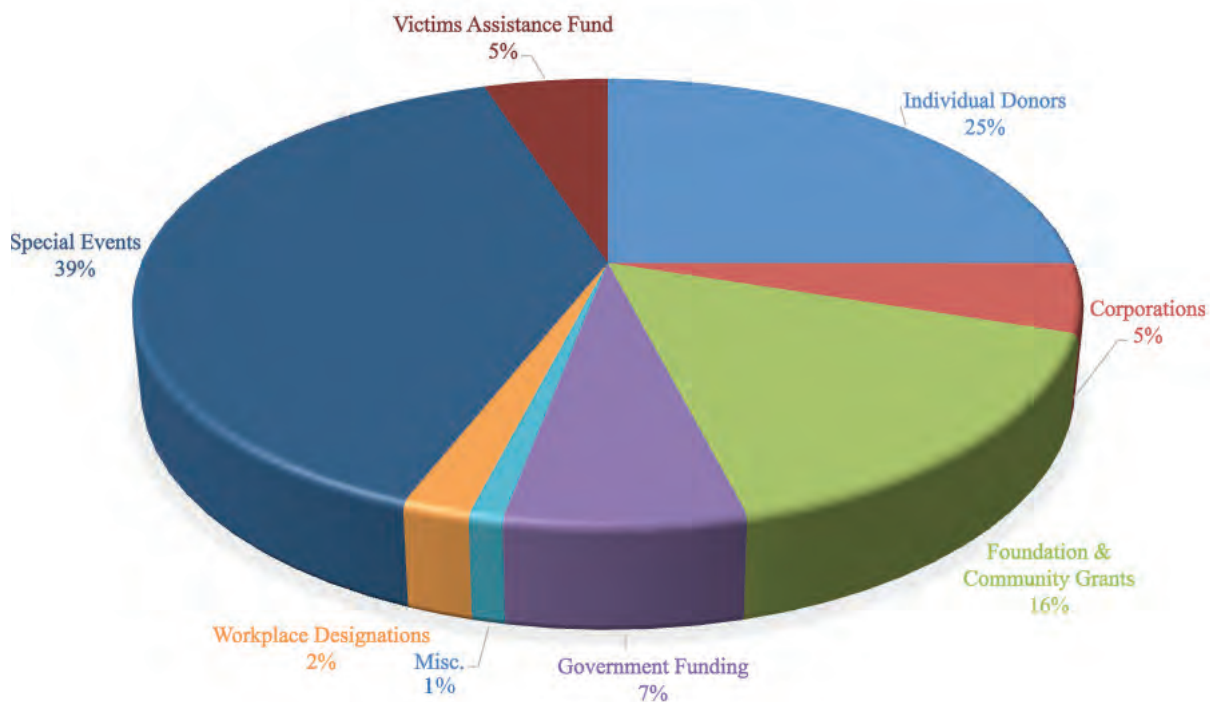
