Fabled Farm Rescue & Sanctuary is a middle TN based 501(c)3 committed to accepting and placing unwanted equines and farm animals in qualified, loving forever homes, while continuing care for the unadoptable animals with medical or behavioral issues through our sanctuary program.

Fabled Farm & Sanctuary has grown in only two years! The Executive Director and others have been able to expand pasture areas and add new shelters for additional types of animals in the programs. A new barn was completed to house special needs small farm animals. It includes a medical room, two cat/kittens rooms, and three stalls. This has allowed the rescue to increase the number of animals helped and take on more animals that need specialized care. With the help of local volunteers, amazing veterinarians, and donors, Fabled Farm has been able to better assist the community and animals in need.

Animals come to Fabled Farm in a variety of ways that include owner surrenders, hoarding or neglect cases, strays, and transfers from rescue organizations when they are at capacity.

First Fabled Farm focuses on rescue, rehabilitation, and rehoming through a gold standard adoption process. We fully vet every animal that comes into the program including vet exams, vaccinations, castrations, spay, dental care, hoof care, and any other needed care. We are proud to accept animals that need socialization or additional training. We use a fear free, positive reinforcement approach to help the animal be ready to find a forever family. Once an animal is healthy and well adjusted, we work to find them the perfect family through a three-step adoption process. This includes an application that includes vet, farrier, and personal reference checks, a meeting with the animal, and a home visit prior to adoption. Many of our adopters enjoy our matchmaking process so much they return for additional animals to join their family.

One of the best examples are two piglets, Hansel and Gretel, that came into the rescue program barely alive. When Fabled Farm went to pick them up, they were outside, in January, in a metal crate that was frozen to the ground. At only a few weeks old they were too young to be away from their mother and to weak from lack of nutrition. After being raced to our vet and receiving round the clock care at the rescue for weeks, the piglets made a full recovery. Not only did they recover, but both were adopted together to work as therapy pigs a non-profit center that focuses on helping families overcome traumatic circumstances and grief. They now enjoy belly rubs all day and are favorites of everyone that visits the center.

Some of the animals that come to Fabled Farm end up in the sanctuary program. Because of lack of care, past abuse, or bad breeding, the these animals have health and/or behavioral issues that make them unsuitable for adoption to the public. These animals continue to receive love, attention, and all daily needed care to live their best lives. Many of our sancturay residents participate in our Community Education
