Genesis addresses the unique needs of our students through the provision of specialized individual education, unique classroom designs, counseling, social work, educational support during and after pregnancy, behavior management, parent support and communication, home-based education, and speech, language and occupational therapies. Students' ages range from 5 yrs - 22 yrs. This is the sole program of the Organization. This program is provided in 5 different locations: (1) Genesis Academy School - special day school located in Davidson County, serving approximately 94 children. (2) Rutherford Academy - special day school located in Rutherford County, serving approximately 71 children. (3) Rutherford County Teen Learning Center and Teen Trax - alternative school for status offenders, annually serves approximately 99 students. (4) Montgomery Teen Learning Center - alternative school for status offenders, annually serves 59 students. (5) Homebound Educational Services - in-home educational support for approximately 228 students.
