Genesis addresses the unique needs of our students through the provision of specialized individual education, unique classroom designs, counseling, social work, educational support during and after pregnancy, behavior management, parent support and communication, home-based education, and speech, language and occupational therapies. Students' ages range from 5 yrs-22 yrs. This is the sole program of the Organization. This program is provided in 5 different locations: (1) Genesis Academy School - special day school located in Davidson County, serving approx. 74 children. (2) Rutherford Academy - special day school located in Rutherford County, serving approx. 45 children. (3) Rutherford County Teen Learning Center - alternative school for status offenders, annually serves approx. 18 students. (4) Montgomery Teen Learning Center - alternative school for status offenders, annually serves 23 students. (5) Homebound Educational Services - in-home educational support for approx. 106 students.
